## **NOTICE OF PERSONAL GUARANTY**

Each undersigned guarantor binds himself jointly, severally and in solido with customer and all other guarantors for the full, faithful, and timely execution of and compliance with all of the obligations, conditions, and stipulations assumed or agreed to by successors and assigns, the payment of all amounts due to Trinity Wire LLC. Without limiting the foregoing, guarantor does hereby unconditionally guarantee to Trinity Wire LLC, it's successors and assigns, the payment in full of any and all amounts and indebtedness, direct of contingent, arising out of, related to or connected with customer's obligations to Trinity Wire LLC in addition to all interest, attorney's fees, costs, and expenses suffered or incurred by customer. Trinity Wire LLC shall not be bound to exhaust its recourse against the customer or any other person before being entitled to payment from guarantor of any amount of money or performance of any obligation, covenant or condition hereby guaranteed.

Guarantor hereby consents to Trinity Wire LLC's use of a non-business consumer credit report on the guarantor in connection with the extension of business credit, which will be used from time to time in connection with the extension and continuation of business credit.
